壹、新型專班簡介 About INTENSE Program

國立成功大學國際產業人才教育專班（以下簡稱：新型專班）提供國際學生在台攻讀學位並於畢業後順利銜接就業的路徑。新型專班透過與企業合作，不僅提供就業機會，亦結合政府獎學金與企業補助，提供學生實質的財務支持。學生於就學期間領取政府獎學金及企業獎助，畢業後需履行相應之留台就業義務。

NCKU International Industrial Talents Education Special Program (INTENSE Program) creates a pathway for international students to pursue degrees in Taiwan and transition seamlessly into employment after graduation. This program collaborates with industry partners to provide not only employment opportunities but also substantial financial support through government scholarships and corporate living subsidies. Students who receive government scholarship and corporate living allowance during their studies are required to fulfill the corresponding post-graduation employment obligation in Taiwan.

貳、申請資格 Application Eligibility

一、身分規定 Identification

符合教育部「[外國學生來台就讀學辦法](#)」、「[僑生回國就學及輔導辦法](#)」及「[香港澳門居民來臺就學辦法](#)」之規定者，方可申請報考。

To be eligible to apply, applicants must qualify for **legal International Student** or **Overseas Chinese Student status** under the Ministry of Education's "[Regulations Regarding International Students Undertaking Studies in Taiwan](#)", or "[Regulations Regarding Study and Counseling Assistance for Overseas Compatriot Students in Taiwan](#)" or "[Regulations Regarding the Study and Residence of Hong Kong and Macao Residents in Taiwan](#)" before application.

備註：本季班僅招收「外國學生」。(每季班招收身分依各該季班招生簡章規定為準)

Note: Only International Students are eligible to apply for the 2027 Spring INTENSE program.

(The eligibility for each intake shall be subject to the admissions brochure for the respective term.)

二、招生國別 Nationality

國家不限。No limitations.

三、學歷規定 Academic

1. 具學士學位者，得申請入學本校碩士班。

Academic qualifications: students with a Bachelor's degree for Master's programs.

2. 學生大學在學成績、大學畢業成績或專科畢業成績，平均成績在班級排名或系排名中上程度。Applicant's academic performance during university (or junior college), including cumulative GPA at graduation or during semesters, should rank above average within the class or department.
3. 已在台的大學/專科國際生，學生前一學年平均成績為班排名之前 50%，且操行成績不低於

80 分或甲等。International students currently studying at universities/colleges in Taiwan must have achieved an average grade in the previous academic year that ranks within the top 50% of their class, and a conduct grade of no less than 80 (Grade A).

四、語言能力資格 Language Qualification

1. 申請入學中文授課班級者，華語文能力測驗（TOCFL）基礎級（Level 2，相當於 CEFR A2）聽、讀 2 項皆須達 A2 級（含）以上（第 1 學年結束前須達 B1 級(含)以上）。
Applicants for Chinese-taught programs must achieve at least Level 2 (equivalent to CEFR A2) on the Test of Chinese as a Foreign Language (TOCFL) in both Chinese listening and reading. By the end of the first academic year, students must reach at least TOCFL Level 3 (equivalent to CEFR B1)
2. 申請入學英文授課班級者，英文能力須達 CEFR B1 級(含)以上。第 1 學年結束前華語文能力測驗(TOCFL) 基礎級(Level 2，相當於 CEFR A2)聽、讀 2 項皆須達 A2 級(含)以上。
Applicants for English-taught programs must have English proficiency at CEFR Level B1 or above. Before the end of the first academic year, students must achieve TOCFL Level 2 (equivalent to CEFR A2) or above in both Listening and Reading.
3. 需符合招生系所額外語言規定。Applicants must meet the additional language requirements of the department they are applying.

- A. **書面初審及系所複審：**本校國際處將針對身份資格、語言能力及申請件等進行書面初審，初審通過者始得進入系所複審（含面試）。

Document Screening and Departmental Review:

NCKU's Office of International Affairs will conduct an initial review of applicants' eligibility, language proficiency, and application documents. Only applicants who pass the initial screening will proceed to the departmental review, which includes an interview.

Note: Please refer to the Required Document section for preparation.

Corporate Interview:

Only applicants who pass the departmental review will proceed to the corporate interview. Applicants who successfully pass the final corporate interview will be recommended for admission to the INTENSE Program.

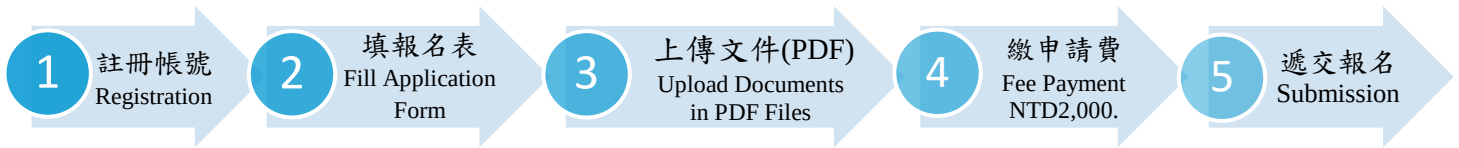

2. 申請流程 Application Process：

(1) 請至本校線上申請系統以個人 Email 註冊一組帳號，並取得申請序號。

Register an account with a personal email address on the NCKU Degree Application for International Students system and obtain an application number. (Each applicant can only register one account at the application portal)

(2) 依序填寫報名表內容，選擇志願系所。

Complete the application form and select the intended department/program.

(3) 上傳所有申請文件，所有文件均需以 PDF 檔案形式上傳。

Upload all required application documents in PDF format.

(4) 繳交申請費用（每位申請者需繳交新臺幣 2,000 元整）。

Pay the application fee (NTD 2,000 per applicant).

(5) 在申請期限內完成並遞交申請件。

Confirm and submit the application within the application period.

3. 注意事項 Note：

(1) 一律線上申請。申請者僅能申請 1 組帳號報名申請；違者則其帳號和申請案件視同無效。

Only accept online applications. Each applicant may register only one account. Applicants with more than one account will be taken as invalid.

(2) 申請者須於截止日期前完成線上申請程序（含繳費）並上傳所有應繳文件，如逾期報名者一概不受理；如表件不齊全致延誤報名者，由考生自行負責；報名費一概不予退還。

Applicants must complete the online application procedure (including payment) and upload all required documents before the deadline. Late, ineligible, or incomplete applications will not be processed. Applicants are responsible for incomplete submissions caused by missing documents. **The application fee is non-refundable.**

(3) 每位申請者至多可申請三個系所，而一個系所至多申請一個組別；申請必繳文件均須繳交，缺件則為無效件，並依志願系所繳交系所額外要求文件。

Each applicant can apply for up to 3 departments/institutes, and, at most, only one group within a department/institute. Required documents are mandatory to be uploaded, if missing any will

be considered as invalid. Additional documents required by the department/institution are mandatory as well.

- (4) 線上申請完成並確認送出後，申請者即不得更改申請資料或申請系所學程。

Once the online application is completed and submitted, applicants cannot modify the application information or the departments/institutes.

- (5) 經錄取者僅能選擇一系所辦理報到及註冊入學。

Applicants can only choose one department/institute to study and enroll if they get 2 or above admission offers.

- (6) 請牢記您線上報名時所填寫之電子郵件，以便之後登入申請系統修改資料、上傳文件以及查詢資格審查與錄取結果。

Applicants should remember the email used for the application and password in order to change their information, upload their documents, and check their application status later on.

- (7) 已錄取之學生，如經發現申請資格不符規定或所繳交之證件有不實、偽造、假借、塗改、學歷資格不具合法效力等情事，即取消入學資格或開除學籍，且不發給任何學力（歷）證明；如在本校畢業後始發現有上述情事者，除勒令繳回撤銷其學位證書外，並公告取消其畢業資格。

If anyone who has applied or received offers of admission into NCKU violates any of the regulations of the Ministry of Education (MOE)“Regulations Regarding International Students Undertaking Studies in Taiwan”, or if any of the documents submitted are found to be fraudulent, forged or altered, it will result in immediate cancellation of admission, deprivation of their recognized status as an NCKU registered student or revocation of their NCKU diploma. No academic certificate will be given.

三、申請費用及繳費方式 Application Fee and Payment

1. 申請費用：新臺幣 2,000 元整。每位申請者可申請三個志願系所。

Application fee: TWD 2,000 will be charged to each applicant. Each applicant could apply for up to **three (3) departments** and with one log-in account only.

2. 繳費方式說明 **Payment Methods**：信用卡繳費。Pay by credit card.

3. 繳費注意事項 Application Fee Reminder：

- (1) 未依規定繳納申請費用者將不予受理申請。

Application for which the application fee is not paid will not be processed.

- (2) 申請費用一經繳納，概不退還。包含申請未完成、放棄申請、申請資格不符、誤繳、重覆繳費等。

When the application fee is paid, no refund will be given for any reason, including withdrawing the application, failing to meet application requirements, paying by mistake and making repeated payments.

- (3) 繳款限以新臺幣或美金計；不接受其他幣值，且不接受郵寄現金或支票。

Payment is only accepted in TWD or USD, we do not accept other currencies. Neither do we accept cash sent by post nor bank checks.

- (4) 繳費單：請保存繳費成功之螢幕截圖或收據等證明，並上傳至線上申請系統。

Payment Slip: Please keep a screenshot or receipt as proof of successful payment and upload it to the online application system..

2. 畢業證書（中文/英文）The Highest Degree Diploma (in Chinese/English)

- (1) 碩士班申請者：繳交學士（以上）畢業證書。

Master's Program applicants: Bachelor's degree diploma (or above).

- (2) 註 1：若畢業證書為中、英文以外之語言，應附中文或英文認證過之譯本。

Note 1: If the diploma is not in Chinese or English, a notarized copy of a translation in English or Chinese is required.

- (3) 註 2：若畢業證書為臺灣學校授予，則不須經由駐外機構驗證。

Note 2: If the degree diploma is notarized from a university in Taiwan, it does not have to be verified.

- (4) 註 3：尚未取得畢業證書之應屆畢業生，需繳交在學學生證影本以資證明；應屆畢業生如獲錄取，則需於註冊時繳交驗證完成之正式畢業證書，否則將取消錄取資格。（不接受預畢業證書）

Note 3: For those expecting to graduate this year and are yet to obtain their diplomas, please submit a copy of the student ID card showing the year of study; graduating students admitted to NCKU must submit the official diploma, verified by ROC overseas institutes at the time of registration, or admission will be cancelled. (The provisional diploma/certificate is not acceptable.)

Note 1: If the transcript is not in Chinese or English, a notarized copy of a translation in English or Chinese is required.

- (3) 註 2：已在台的大學/專科國際生，學生前一學年平均成績為班排名之前 50%，且操行成績不低於 80 分或甲等。

Note2: International students currently studying at universities/colleges in Taiwan must have achieved an average grade in the previous academic year that ranks within the top 50% of their class, and a conduct grade of no less than 80 (Grade A).

- (4) 註 3：若成績單為臺灣學校所授予，則不需經由駐外機構驗證。

Note 3: Transcripts from universities in Taiwan do not need verification.

- (1) 請提供新臺幣 120,000 元(約 4,000 美元)以上之中文或英文版財力證明書。(請依最新匯率換算，並清楚標示幣別為美元或是新台幣)。

Bank deposit statement of at least NTD\$120,000 (approx. US\$4,000) and above must be provided, showing sufficient financial support for the one's entire stay during the time of study.

- (2) 若存款證明非申請者本人帳戶，須附上資助者親筆聲明書，敘明與申請者之關係並保證負擔申者在臺留學所有費用。

If the financial statement is not in the name of the applicant, a declaration with a signature from the sponsor must be included, stating the relationship with the applicant and guaranteeing responsibility for all of the applicant's expenses in Taiwan.

Academic thesis or relevant publications (for Ph.D. programs applicants only)

12. 其他有利申請文件 Other supporting documents or project reports

- (1) 請依「招生系所及名額資訊」中各系所之額外文件要求及規定。例如：中文自傳、工作經驗證明、作品集、指導教授同意書等。

Detailed information regarding additional requirements of different departments/institutes can be obtained from "Requirements of Departments". e.g. Chinese autobiography, proof of employment, portfolio, etc.

- (2) 註 1：系所將視需要進行視訊面試或筆試，將由系所另行通知。

Note 1: The department will conduct oral test or online interview if needed, and will notify separately by the department.

伍、新型專班獎學金資訊 INTENSE Program Scholarship Information

一、產學獎助金 Government Scholarship

(由行政院國家發展基金提供，若已領取我國政府其他獎助學金者，不得重複申請)

(Provided by the National Development Fund of the Executive Yuan. Those who have already received other scholarships or grants from Taiwan government are not eligible for repeated application.)

1. 來台單程機票補助 (限經濟艙直飛)：

One-way Airfare Subsidy to Taiwan (Economic Class Direct Flight Ticket to Taiwan)

- (1) 補助上限：新南向區域國家學生新臺幣 9,000 元；歐美區域國家新臺幣 35,000 元。(核實報支)

Maximum: NT\$9,000 for students from Asian countries. NT\$35,000 for students from European and American countries. (Receipts required for reimbursement)

- (2) 須檢附機票收據以供核銷與查驗，並以收據開立當日之臺灣銀行美金對新臺幣匯率計算。原已在台就學之國際生不予補助。

A flight ticket and receipt are required for reimbursement and verification. The calculation shall be based on the Bank of Taiwan's USD to TWD exchange rate on the date of receipt issuance. International students who already study in Taiwan are not eligible for this subsidy.

2. 初次來台行政費用*

Administrative Expenses for the First Arrival in Taiwan:

- (1) 補助上限：新南向區域國家及其他國家之學生新臺幣 10,000 元；歐美區域國家學生新臺幣 25,000 元。(原已在台就學之國際生不予補助)

Maximum: NT\$10,000 for students from Asian countries; NT\$25,000 for students from European and American countries. (International students who already study in Taiwan are not eligible for this subsidy.)

- (2) 採一次性補助：包含來台前的健康檢查、簽證、文書驗證費用(核實報支)

One-time subsidy: Include pre-departure health check fee, visa fee, document verification fee. (Receipts required for reimbursement.)

3. 學雜費補助 (最多 2 年)

Tuition subsidy (up to 2 years):

- (1) 每學期學雜費補助上限新臺幣 50,000 元，依學生實際應繳交給學校的學雜費給予補助，每年補助上限為 10 萬元。

Maximum NT\$50,000 per semester. Tuition subsidies will be provided based on the actual tuition and miscellaneous fees that students are required to pay to the school, with an maximum annual subsidy of NT\$100,000.

- (2) 入學第一年即提供學雜費補助。第二年第 1 學期結束前華語文能力測驗(TOCFL) 中文授課班級者聽、讀 2 項皆須需達 B1 級(含)以上、英文授課班級者聽、讀 2 項皆須達 A2 級(含)以上，且需通過學校與合作企業審查成績與表現後，擇優核給學雜費補助。倘未通過華語能力測驗者，第 2 學年第 2 學期即不得領取學雜費補助。

All international students will be granted tuition subsidy NTD\$100,000 after admission for the first year.

Before the end of the first semester of the second academic year, students who meet the below requirements and pass the performance review conducted by the NCKU and the collaborating enterprise will be continued awarded tuition subsidies:

- For students in Chinese-taught programs: Both the Listening and Reading components of the TOCFL must reach Level B1 or above.
- For students in English-taught programs: Both Listening and Reading must reach TOCEL Level A2 or above.

If a student fails to meet the Chinese TOCFL requirement, he or she will not be eligible to receive the tuition subsidies in the second semester of the second academic year.

4. 義務條款：領取產學獎助金之畢業生，須依其受獎年限履行相應年限之留臺工作義務。例如：領取 1 年產學獎助金者，具有 1 年（12 個月）留台就業義務；領取 2 年產學獎助金者，具有 2 年（24 個月）留台就業義務。

Obligations: Graduates receiving the government scholarship are required to fulfill a corresponding period of work obligation in Taiwan based on the number of years they received the scholarship. For example, students who receive 1 year of government scholarship are obligated to work in Taiwan for 1 year (12 months). Students who receive 2 years of government scholarship are obligated to work in Taiwan for 2 years (24 months).

二、企業生活津貼 Corporate Living Allowance

(Provided by cooperating company)

1. 生活津貼：每人每月至少新臺幣 10,000 元。

Living Allowance: NT\$10,000 / per month at least.

2. 義務條款：獲聘學生留用就業之義務期程，與領取企業生活津貼期程相同，即領取企業 2 年生活津貼者，具有於該企業工作義務 2 年。

Obligations: The employment obligation period for hired students corresponds to the duration of the corporate living allowance received. For example, students who receive 2 years of corporate living allowance are required to work at that company for 2 years.

3. 註 1：合作企業將與系所共同評估學生之表現。

Note 1: The cooperated company will evaluate students' performances with the department together.

4. 註 2：上述獎學金之詳細規定（如歸還原則等），將於錄取後另行簽署之合約中明定。

Note 2: Detailed regulations regarding the above corporate living allowance, like repayment principles, will be specified in a separate contract signed after admission.

三、產學獎助金歸還原則 The Government Scholarship Repayment Principles

1. 屬不可歸責於學生之原因，無須繳還產學獎助金：

Due to reasons not attributable to the student, the government scholarship does not need to be repaid.

- (1) 原合作企業因營運調整，於學生在學期間停止提供生活津貼，又學生經學校媒合仍無法覓得其他企業願意續予補助生活津貼者，致學生中途退出專班者。

If the cooperating enterprise suspends the provision of living allowance due to operational adjustments during student's period of study, and student, after assistance from the university, is unable to find another enterprise willing to continue the subsidy, resulting in student's mid-program withdrawal from the INTENSE Program, student shall not be required to repay the received government scholarship.

- (2) 原合作企業因營運調整，於學生畢業時無職缺可聘用，又學生經學校進行就業輔導及媒合其他企業仍無法覓得適合企業聘僱者。

If the original cooperating enterprise has no job openings at the time of the student's graduation due to operational adjustments, and the student, even after employment counseling and referral efforts by the university, is unable to secure employment with another suitable enterprise, the student shall not be required to repay the received government scholarship.

- (3) 合作企業於學生就業期間有勞動基準法第十四條第一項規定情形，致學生提出終止契約，又學生經學校進行就業輔導及媒合，仍無法覓得適合企業接續聘僱者。

If the cooperating enterprise, during student's period of employment, violates any provision under Article 14, Paragraph 1 of the Labor Standards Act, causing student to terminate the contract, and student, even after employment counseling and referral by the university, is unable to find another suitable employer, student shall not be required to repay the received government scholarship.

- (4) 學生死亡、因重大疾病或意外事故不能繼續就學或就業，經衛生福利部新制醫院評鑑合格之教學醫院以上層級，開立認定無法繼續就學或就業證明者，或因事故致家庭巨變無法繼續就學或就業，經學校查證屬實者。

If student is unable to continue studies or employment due to death, serious illness, or accident, and is issued a certificate by a teaching hospital of or above the level accredited by the Ministry of Health and Welfare confirming the inability to continue; or if student is unable to continue studies or employment due to major family changes caused by unforeseen incidents, and the university verifies the case to be valid, student shall not be required to repay the received government scholarship.

2. 屬可歸責於學生之原因，應繳還產學獎助金：

Due to reasons attributable to the student, the government scholarship must be repaid:

- (1) 就學期間因個人因素中途退出專班，如申請轉學、轉系、休學返國，經學校輔導後仍放棄繼續就讀專班、或經學校依學則退學、開除學籍等情形，學生應全額返還已領之獎助金。

If student withdraws from the INTENSE Program due to personal reasons during their studies, such as transferring to another school, changing majors, taking a leave of absence to return home, and after counseling from the school still decides not to continue the Program or is expelled from the school according to the regulations, student shall fully repay the received government scholarship.

- (2) 學生學習表現不佳，未通過學校及企業評核標準，並經學校輔導後仍無改善且依學則處以退學、開除學籍等情形，學生應全額返還已領之獎助金。

If the student performs poorly academically, fails to meet the assessment standards of the school and enterprises, and, after counseling from the school, shows no improvement and is subsequently expelled from the school according to the regulations, the student shall fully repay the received government scholarship.

- (3) 學生畢業後選擇不至合作企業或相關產業領域就業，或就業後違反公司規定被依法終止勞動契約，並經學校輔導後仍無改善者，學生應返還已領之產學獎助金。

If the student chooses not to work in a cooperating company or related industry after graduation, or if the student is legally dismissed due to violation of company regulations and shows no improvement after receiving guidance from the university, the student shall fully return the government scholarship funds that have already been received.

3. 學生於合作企業就業期間未滿受領產學獎助金年限(領取 1 年產學獎助金者須留臺就業 12 個月、領取 2 年產學獎助金者須留臺就業 24 個月)：應依其未就業之月數比例繳還產學獎助金；不滿一月者，以一月計。(如就業地點未在國內，應依未於國內就業之月數比例繳還產學獎助金；不滿一月者，以一月計。) 若因中途轉換工作，考量尋職所需時間，參加 2 年計畫者，於履約日起算，應於 2 年 6 個月內完成留臺就業 2 年之義務；若未就業時間累計超過半年，則應依其未就業之月數比例償還產學獎助金。(參加 1 年計畫者，於履約日起算，應於 1 年 6 個月內完成留臺就業 1 年之義務；若未就業時間累計超過 6 個月，則應依其未就業之月數比例償還產學獎助金)。

If a student does not complete the required period of employment corresponding to the years of government scholarship received (i.e., 12 months of employment in Taiwan for 1 year of scholarship; 24 months for 2 years of the scholarship), the student must repay the scholarship based on the proportion of the months not fulfilled. Any period of less than one month will be counted as one full month. (If the employment location is outside Taiwan, repayment will be calculated based on the months not employed in Taiwan; any period less than one month will be counted as one month.)

In cases where the student changes jobs during the period of obligation, additional time may be allowed for job searching. For students in the 2-year program, starting from the

date the obligation begins, they must complete 24 months of employment in Taiwan within 30 months. If the accumulated period of unemployment exceeds 6 months, the student must repay the scholarship proportionate to the months not employed. For students in the 1-year program, they must complete 12 months of employment in Taiwan within 18 months from the start of the obligation. If the accumulated unemployment period exceeds 6 months, the student must repay the scholarship proportionate to the months not employed.

四、企業生活津貼歸還原則 The Corporate Living Allowance Repayment Principles

1. 屬不可歸責於學生之原因，無須繳還生活津貼：

Due to reasons not attributable to the student, the corporate living allowance does not need to be repaid.

- (1) 企業若因營運調整，於學生在學期間停止提供學生生活津貼，屬不可歸責於學生之原因，企業不得向學生追回已請領之生活津貼。

If the company suspends the provision of the living allowance during the student's study period due to operational adjustments and the reason is not attributable to the student, the company shall not reclaim the corporate living allowance that has already been disbursed.

- (2) 合作企業因營運調整，於學生畢業時無職缺可聘用。

If the cooperating enterprise has no job openings at the time of the student's graduation due to operational adjustments, the enterprise shall not reclaim the living allowance already disbursed.

- (3) 合作企業於學生就業期間有勞動基準法第十四條第一項規定情形，致學生提出終止契約時，學生免償還已受領之生活津貼。

If the cooperating enterprise, during the student's employment period, violates any provision under Article 14, Paragraph 1 of the Labor Standards Act, leading the student to terminate the contract, the student shall be exempt from repaying the living allowance received.

- (4) 學生死亡、因重大疾病或意外事故不能繼續就學或就業，經衛生福利部新制醫院評鑑合格之教學醫院以上層級，開立認定無法繼續就學或就業證明者，或因事故致家庭巨變無法繼續就學或就業，經學校查證屬實並通報企業者，得免履行就業義務及免償還受領之生活津貼。

If student is unable to continue studies or employment due to death, serious illness, or accident, and is issued a certificate by a teaching hospital of or above the level accredited by the Ministry of Health and Welfare confirming the inability to continue; or if student is unable to continue due to major family changes caused by unforeseen incidents, and the university verifies and reports the case to the enterprise, student may be exempt from fulfilling the employment obligation and repaying the corporate living allowance received.

2. 屬可歸責於學生之原因，得於合約內容載明追回條件情況下，由企業向學生追回生活津貼

Due to reasons attributable to the student, and provided that the conditions for such recovery are clearly specified in the contract, the enterprise may reclaim the living allowance from the student.

- (1) 就學期間因個人因素中途退出專班：如申請轉學、轉系、休學返國，經學校輔導後仍放棄繼續就讀專班、或經學校依學則退學、開除學籍等情形。

If student withdraws from the INTENSE Program during the study period due to personal reasons such as transferring schools, changing majors, or taking a leave of absence to return home, and after counseling by the school still decides not to continue the Program, or is dismissed or expelled by the school according to academic regulations, the enterprise may reclaim the corporate living allowance from the student.

- (2) 學生學習表現不佳，未通過學校及企業評核標準，經學校輔導後仍無改善，致企業不予聘用者。

If the student performs poorly and fails to meet the evaluation standards of the school and the enterprise, and shows no improvement after counseling, resulting in the enterprise deciding not to offer employment, the enterprise may reclaim the corporate living allowance from the student.

- (3) 學生畢業後 3 個月內，未至合作企業就業。

If the student does not begin employment at the cooperating enterprise within three months after graduation, the enterprise may reclaim the corporate living allowance from the student.

- (4) 學生於合作企業就業期間未滿受領生活津貼年限：應依其未就業之月數比例償還生活津貼；不滿一月者，以一月計。

If the student's employment period at the cooperating enterprise is shorter than the duration for which the living allowance was received, the student shall repay the corporate living allowance proportionally based on the number of months not employed; if less than one month, it shall be counted as one month.

陸、校園資訊與支援 Campus Information and Support

一、報到及註冊入學 Enrollment and Registration

1. 錄取生應依錄取通知規定，在指定期限前登入申請入學系統回覆就讀意願。逾期未於申請系統回覆就讀意願者，即以自願放棄錄取資格論。

All admitted students must confirm their acceptance for studies online before the deadline. Applicants who fail to do the procedure will be considered as giving up their offer of admission.

2. 錄取者有意願至本校就讀者，應依錄取通知之規定辦理各項註冊入學或報到程序，並於註冊時繳驗錄取通知所列各項文件。如未繳交完成者，視為註冊未完成；未報到者則視為自願放棄入學資格。

All admitted students should register with the relevant offices by the designated time, following administration procedures. The required documents will be stated and detailed in the admission package. Failure to complete the registration procedure will be considered as giving up their offer of admission.

3. 錄取者應於註冊時繳交經我國駐外使領館、代表處、辦事處或其他經外交部授權機構驗證之外國學校最高學歷證明文件之正本（經本校查核存檔後歸還）；若畢業證書是中、英文以外的語文，應附中文或英文認證過的譯本；若畢業證書為臺灣學校所授予，則不需經由駐外機構驗證。

All admitted students must provide the highest degree diploma, verified with official stamps by the ROC embassies, consulates, or missions abroad or by other notary institutes authorized by the Ministry of Foreign Affairs, ROC (This document will be returned after being examined and filed). If the diploma is not in Chinese or English, a notarized copy of a translation in English or Chinese is required; if the degree diploma is notarized from a university in Taiwan, it does not have to be verified.

4. 錄取生應依「外國學生來臺就學辦法」或「僑生回國就學及輔導辦法」之規定，於註冊時檢附已於國外投保自入境當日起至少六個月效期之醫療及傷害保險或委由本校代為購買六個月效期之醫療及傷害保險。如已具有我國全民健康保險，則檢附相關保險證明文件。保險證明如為國外所發者，應經駐外館處驗證。

All admitted students must provide proof of medical and personal accident insurance from their home country valid from entering into the ROC and up to at least six months upon enrollment in accordance with or purchase the six-month medical and accidental insurance coverage through NCKU. Students already insured by the ROC's national health insurance must also provide proof of insurance. If the proof of insurance is issued outside of Taiwan, it should be verified by ROC representative offices in the country where the document is issued.

5. 其他注意事項 Related notes：

- (1) 已報名或錄取之學生，如經發現申請資格不符教育部「外國學生來臺就學辦法」或「僑生回國就學及輔導辦法」或「香港澳門居民來臺就學辦法」之規定，或繳交之證件有不實、偽造、假借、塗改、學歷資格不具合法有效等情事，即取消其申請、入學

資格、開除學籍或撤銷其本校畢業資格與學位證書，且不發給任何學歷（力）證明。

If anyone who has applied or received offers of admission into NCKU violates any of the regulations of the Ministry of Education (MOE) “Regulations Regarding International Students Undertaking Studies in Taiwan”, or “Regulations Regarding Study and Counseling Assistance for Overseas Compatriot Students in Taiwan”, or “Regulations Regarding the Study and Residence of Hong Kong and Macao Residents in Taiwan” or if any of the documents submitted are found to be fraudulent, forged or altered, it will result in immediate cancellation of admission, deprivation of their recognized status as an NCKU registered student or revocation of their NCKU diploma. No academic certificate will be given.

- (2) 外國學生經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再依外國學生來臺就學辦法申請入學。International students who withdraw from university/college after admission due to behavior issues, poor academic performance, or a conviction under the Criminal Code may not thereafter apply again for admission under “MOE Regulation Regarding International Students Undertaking Studies in Taiwan”.
- (3) 僑生經入學學校以操行或學業成績不及格、違反法令或校規情節嚴重致遭退學或喪失學籍者，不得依僑生回國就學及輔導辦法申請入學。If the educational institution in Taiwan where the overseas compatriot student was studying considers that the student’s conduct or academic performance was unsatisfactory, or if the student violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of the regulations governing student awards and penalties, the student had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan based on the provisions.
